Booking: A non-refundable deposit per-person is required to reserve a space on a tour. The deposit amount is due immediately in order to ensure your space/reservation. Final payment is due on the date stated on your invoice. All payments made towards the balance will not be refunded. If traveling with a roommate please be aware that you will be responsible for the additional cost for Single Occupancy in the event of cancellation and if another roommate cannot be found. Cancellations, Refunds and Trip Interruptions: Due to the nature of group travel and contracting with service providers, deposits and payments made cannot be refunded.
